Derbyniwyd gohebiaeth wedi hyn gan Ysgrifennydd y Cabinet dros Ynni, Cynllunio a Materion Gwledig yn gwahodd Cyngor Sir Ddinbych (CSDd) a Cyngor Bwrdeistref Sirol Conwy (CBSC) i baratoi Cynllun Cynllunio Lleol ar y Cyd (CDLI). **Update: Denbighshire Replacement Local Development Plan**

*We are writing to update you on the progress on the production of the replacement Local Development Plan.*

*Following approval by Council on 5th December 2017, the LDP Review Report and Replacement LDP Delivery Agreement were formally submitted to Welsh Government. Correspondence was subsequently received from Cabinet Secretary for Energy, Planning and Rural Affairs inviting Denbighshire County Council (DCC) and Conwy County Borough Council (CCBC) to prepare a Joint Local Development Plan (LDP). The joint response set out the preference that individual LDPs should be produced.*

*The Cabinet Secretary has recently confirmed that Denbighshire can progress the LDP review on an individual basis and a revised Delivery Agreement was approved by Welsh Government on 22nd May 2018.*
